Bart assists clients with liquor licensing services such as obtaining alcoholic beverage permits or liquor licenses, transfer and renewal applications and charitable gaming licenses, negotiates settlement agreements concerning alleged violations issued by the Indiana State Excise Police, and helps clients with tax issues (tax protests) before various taxing authorities.

Bart has extensive experience at the state and local government level. Bart served as the Chairman of the ATC where he oversaw the licensure, regulation and enforcement of all businesses that hold alcoholic beverage permits (liquor licenses) and tobacco certificates in the State of Indiana.

Prior to being named the Chairman of the ATC, Bart served as Legislative Liaison and Executive Assistant to Governor Frank O'Bannon. During Bart's tenure in the O'Bannon administration, Bart helped coordinate all legislation affecting state agencies and worked closely with the members of the Indiana General Assembly to achieve the Governor's legislative agenda.

Prior to joining the Governor's Office, Bart served as Chief Legal Counsel to the Senate Democrat Caucus and City Attorney in Marion, Indiana where he served as legal counsel to Mayor William Henry, and various agencies and boards, including the Marion Redevelopment Commission, the Marion Advisory Plan Commission, and the Board of Public Works.

Bart has also served as Deputy Attorney General under Attorneys General Pam Carter and Jeff Modisett where he represented the State of Indiana before the Indiana Supreme Court and Court of Appeals.

Bart has been named a Sagamore of the Wabash by two Indiana governors, Governor Frank O'Bannon and Governor Joseph E. Kernan.
